



NOTIFICATION OF TREASURY SHARE BUYBACK

BETWEEN 11 NOVEMBER AND 15 NOVEMBER 2019

Within the buyback plan (the "Plan") – as communicated on 14 December 2018 and launched on 19 December 2018, in compliance with the resolution passed by the Shareholders' Meeting held on 14 December 2018 – Fine Foods & Pharmaceuticals N.T.M. S.p.A. announces that between 11 NOVEMBER and 15 NOVEMBER 2019 it bought back, on the AIM Italia market (AIM) managed by Borsa Italiana, no. 11,440 treasury shares (corresponding to 0.0499% of the Company's share capital) at an average price of Euro 10.7506 per share for a total amount of Euro 122,987.

On the basis of the information given by Banca Akros – the appointed intermediary to manage the Plan in full autonomy and independence – here above are the details of the transactions on a daily basis:
