

NOTIFICATION OF TREASURY SHARE BUYBACK

BETWEEN 2 MARCH AND 6 MARCH 2020

Within the buyback plan (the “Plan”) – as communicated on 14 December 2018 and launched on 19 December 2018, in compliance with the resolution passed by the Shareholders’ Meeting held on 14 December 2018 – Fine Foods & Pharmaceuticals N.T.M. S.p.A. announces that between 2 MARCH and 6 MARCH 2020 it bought back, on the AIM Italia market (AIM) managed by Borsa Italiana, no. 16,269 treasury shares (corresponding to 0.0694% of the Company’s share capital) at an average price of Euro 11.0100 per share for a total amount of Euro 179,122.

On the basis of the information given by Banca Akros – the appointed intermediary to manage the Plan in full autonomy and independence – here above are the details of the transactions on a daily basis:
