Fine Foods & Pharmaceuticals N.T.M. S.p.A. as part of its treasury share buyback programme (the Programme) – which was launched on 15 May 2023 implementing the 9 May 2023 Shareholders' Meeting resolution – in the 2 OCTOBER – 6 OCTOBER 2023 period, purchased 3,246 treasury shares, (equal to 0.0127% of the share capital), at an average weighted price of € 8.2581, for a total value of € 26,805.89.

The buyback was made through the intermediary Banca Akros, LEI Code 549300GRXFI7D6PNEA68.
