



## TREASURY SHARES BUYBACK INFORMATION

S.p.A. as part of its treasury share buyback programme (the Programme) – which was launched on 15 May 2023 implementing the 9 May 2023 Shareholders' Meeting resolution – in the 23 OCTOBER – 27 OCTOBER 2023 period, purchased 2,805 treasury shares, (equal to 0.0110% of the share capital), at an average weighted price of  $\notin$  7.8935, for a total value of  $\notin$  22,141.29.

The buyback was made through the intermediary Banca Akros, LEI Code 549300GRXFI7D6PNEA68.
