S.p.A. as part of its treasury share buyback programme (the Programme) – which was launched on 15 May 2023 implementing the 9 May 2023 Shareholders' Meeting resolution – in the 29 JANUARY – 2 FEBRUARY 2024 period, purchased 2,118 treasury shares, (equal to 0.0083% of the share capital), at an average weighted price of \notin 9.0197, for a total value of \notin 19,103.76.

The buyback was made through the intermediary Banca Akros, LEI Code 549300GRXFI7D6PNEA68.
